DESIGNATION OF AREA FOR SALE OF REAL ESTATE

WHEREAS, the Cooke County Commissioners Court must comply with Section 51.002 of the Texas Property Code which in part states:

The commissioners court shall designate the area at the courthouse where the sales are to take place and shall record the designation in the real property records of the county.

and;

WHEREAS, a secondary designated area may be required when the primary designated area is not available, and;

NOW, THEREFORE, BE IT ORDAINED BY THE COOKE COUNTY COMMISSIONERS COURT:

THAT, the Cooke County Commissioners Court designates the area immediately outside and within fifty (50) feet of the first floor east entrance to the courthouse as the primary sales area and the area immediately outside and within thirty (30) feet of the first floor west entrance to the courthouse as the secondary sales area. This designation shall be effective January 1, 1998.
