Notice is hereby given that on **August 17, 2020** the Commissioners Court of Cooke County, Texas will hold a meeting at **10:00 A.M.** in the Commissioners Courtroom, Cooke County Courthouse, First Floor, Gainesville, Texas.

**LIMITED SEATING AVAILABLE**  
**15 persons allowed to be seated at a time.**

In accordance with the Governor's Public Health Emergency Declaration on March 16, 2020, certain provisions of the Texas Open Meetings Act have been suspended to allow for video and telephonic communications. Given these limitations, the current Cooke County Public Health Emergency Declaration restrictions and the Center for Disease Control recommendation limited general public seating will be allowed in the Commissioners Courtroom. Additionally, public access and participation will be available through the call-in number below as well as live streamed via the link below.

Should anyone wish to address the court on any agenda item, they must call (940)668-5435 or email [cathy.lloyd@co.cooke.tx.us](mailto:cathy.lloyd@co.cooke.tx.us) at least one (1) hour prior to the meeting, or by signing up in person, at the County Judge's office, at least 15 minutes prior to the start of the meeting. Those individuals will then be allowed to participate using the call-in number below or by speaking in person. Public comment will be limited to not more than 1-hour (60 minutes) total for this topic.

Each person will be allotted the same amount of time, which will be determined based upon how many individuals sign up to speak, but no more than 5 minutes per person.




